# GLOBAL WEB 5.0 CONFERENCE SPEAKERS & PANEL MEMBERS BRIEFING PACK

Dear Speaker/Panelist,

Thank you for accepting our invitation to be a part of the **Global Web 5.0 Conference in Singapore on 1 Nov 2022**. We are excited to have you and we are confident that your presence will help make this event a great success.

To help you get ready for the conference, we have prepared this simple note to share the following:

## What is Web 5.0

At present, there is no standard definition of what Web 5.0 is.

Based on 101Blockchains.com, Web 5.0 is defined as:

*“Web 5.0 has been designed as a decentralized web platform that can allow the flexibility and resources for developing decentralized web applications. The primary objective of web 5.0 would focus on empowering users to reclaim control and ownership of their data. As of now, the web 5.0 version is still under development. However, some experts have pointed out that web 5.0 would be more of a combination between web 2.0 and web 3.0.”*

Based on Business Standard, they define Web 5.0 as:

*“Web 5.0 will have a series of decentralised apps and protocols. Instead of multiple blockchains, Web 5.0 developers are trying to leverage only Bitcoin and build everything on top of it. In Web 5.0, users will hold a digital wallet that securely manages their identity, data, and authorisations for external apps and connections.*

*For instance, a user can use his or her wallet to log in to a new decentralised app. They may not need to repeatedly create fresh profiles and log in to new applications as Web 5.0 will aim to give users a “decentralised identity” allowing them to seamlessly move from one app to another. User data, rather than getting stored with third-party products and services, will be controlled by users and only be exposed with their permission.”*

Coinllectibles and Marvion define Web 5.0 as:


*“The seamless interoperability between centralised (Web 2.0) and decentralised (Web 3.0) apps and platforms for the primary purpose of achieving the ideal balance of user experience, control and ownership.”*

To promote a robust discussion, there will **not** be a single standard definition of what Web 5.0 is during the conference. **Speakers and panelists are encouraged to share what Web 5.0 means to them during the conference.**

## Technology trends and their implication on Web 5.0 development.

Based on a World Economic Forum article dated Oct 2021; McKinsey has identified 10 key technology trends that will shape the coming decade (see Figure 1). The wide adoption of these technologies will inevitably have some influence in the development of Web 5.0. Hence, speakers and panel members are encouraged to share their views on how they see these technologies play a part (if any) in the Web 5.0 development. ## What is DOT

During this conference, you may come across the term “DOT”. DOT is the abbreviation of “Digital Ownership Token”. This term was coined by Coinllectibles and Marvion, and it refers to a NFT that is solely used as a provenance and authentication solution for a real underlying asset. To illustrate, in the case of a physical ceramic collectible, a DOT buyer gets both the DOT as well as the physical item. Within the DOT, it contains legal agreements, supplementary reports, media files, etc., which are uploaded on the blockchain. Owners will subsequently be able to trade these DOTs, while the physical assets are held in custody by an escrow and/or custody agent.

## Themes for the Global Web 5.0 Conference

At present, we are working towards having more than 1,000 attendees RSVP for the event. We expect a mix of ecosystem stakeholders (i.e. policy makers, investors, etc.), entrepreneurs, creators (i.e. artists, influencers, etc.) and consumers (i.e. crypto and NFT enthusiasts). Unlike Web 1.0 or Web 2.0 – which are primarily technology focused, we believe a cross disciplinary approach is more appropriate when looking at Web 5.0 development. Hence, it is this view that has shaped how we have put the event together. In view of the wide profile of attendees, we have identified 4 broad themes for the conference (see Figure 2).

# VISIONARIES OF THE GLOBAL WEB 5.0 CONFERENCE



**Dr Herbert Lee** was trained as an engineer, and he became a chartered engineer in 1982. In 2011, Dr Lee received his Doctorate in Engineering from the Hong Kong Polytechnic University, and his area of specialisation was in knowledge management and semantics. In 2015, he was appointed to become a Senior Academician by the Hong Kong Institute of Asian Knowledge Management. That same year, Dr Lee assisted China's State Administration of Radio and Television to research on the transmission standards of autostereoscopic 3D devices. In 2018, Dr Lee was appointed by the China Academy of Management Sciences to become the Executive Director of the Shenzhen Branch. Dr Lee has over 20 years of management experience in the high-tech industry. Over the years, Dr Lee has won numerous awards for outstanding scientific and technological innovations. Some of these more significant awards include: Hong Kong Awards for Industry and Commerce 2016, Hong Kong Electronics Industry Gold Award 2017, and Excellence in Science and Technology Awards – Nobel Scholars Series for Enterprise Award 2017. In 2018, Dr Lee led a team to participate in the 46th Geneva International Invention Exhibition and won the “Special Award of the Judges”. In the same year, Dr Lee also won the Grand Award for the Science and Technology Achievement Award of the Hong Kong Awards for Industry and Commerce. Under Dr Lee's leadership, the portfolio of companies under XBE ([www.xbe.com](http://www.xbe.com)) collectively owns more than 100 registered patents and 800 authorized patents worldwide. In his latest achievement this year, he was awarded as the Honorary Fellow of the Centre for Business Sustainability of the Hong Kong Chinese University.

**Dr Craig Wright** established nChain in 2015, where he is the Chief Scientist and where his ideas have led to several thousand patent applications. Dr Wright has more than 30 years of experience in information technology and IT security, having conducted more than 1,200 engagements for private and governmental organisations. Dr Wright worked on systems protecting the Australian Stock Exchange and helped design the architecture for the world's first online casino. Dr Wright is currently a candidate for two additional PhDs, in Law and Applied Mathematics.

1. **Josep Aliagas – Managing Partner at DIS Capital.** Josep is an international M&A and financing expert in technology, infrastructure and energy projects. With two successful exits in the tech industry, he was the founder of Ready Soft in 1994, one of the first ISPs in the world, sold to World Online and IPOed in 2000. Shortly afterward, he founded Arena Mobile a mobile content company with subsidiaries in more than 15 countries in Europe, Asia, North, South America, and Africa, serving telcos in over 100 countries. Arena was sold in 2008. Josep started his professional career as a KPMG auditor in 1991. He is also a co-founder of Vitaloid, and Digital Investments, as well as angel investor in several start-ups. He helped fund billion-dollar infrastructure and energy projects in Central and South America, Africa, and Asia in cooperation with Chinese State Owned Enterprises such as Power China, Gezhoubu, and CMCC among others. Josep has extensive business and financing experience having worked all over the world. He is fluent in seven languages including: Spanish, Chinese, English, French. Holds a degree in business and economics at the University of Barcelona and completed the Blockchain strategy program at the University of Oxford's Saïd School of Business and the Private Equity and Venture Capital at Università Bocconi. Josep is a member of the British Blockchain Association and Silicon Valley Hub coordinator of MyData Global and a mentor at Singularity University start-up programs.
